

Safety Management Systems (SMSs) are implemented onboard ships and yachts to promote a true safety culture aimed at protecting the persons onboard, the environment, and the vessels themselves. They also ensure compliance with the relevant international and national safety and pollution requirements.

Manta Maritime provides easy-to-use SMS documentation for yachts of all sizes and types, tailored to exactly meet each client's requirements, plus those of the various certifying authorities.

We have made our systems very straightforward to implement and a minimal burden on the crew by focusing only on procedures that relate to safety and the environment, and by developing various facilities for fast browsing, searching and cross-referencing.

Our product for yachts under 500GT is called s@fe&simple, the two main versions of which are compared in the table below. The **basic** system is primarily for crew that either already have operational procedures or wish to write their own, whilst the **complete** version requires minimal input from the crew and includes Manta Maritime's shore-based support.

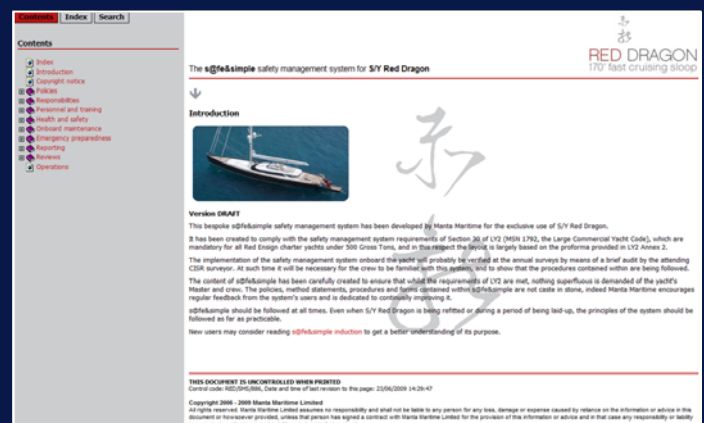
When properly implemented, both versions can be used to comply with the SMS requirements of the commercial yacht codes: (LY2 (for UK, Bermuda, British Virgin Islands, Cayman Islands, Gibraltar, Isle of Man), Cook Islands, Marshall Islands, etc.).

Custom solutions are also available for clients that require something in between the **basic** and **complete** versions.
